It has been reported that, in some cases AGM/Sub Area Manager's have not released selected employees who have been transferred to other Areas, resulting in non-compliance of Office Order in respect of their postings to other Areas against the requirement which has resulted into non-attainment of objectives for which they have been selected. It has also resulted into building up of pressure from others sections for lobbying for their retention in their existing areas. This has been viewed seriously by the Competent Authority.

Hence, it is hereby communicated that if the employees selected and posted in other Areas are not released within 15th December, 2017, their selection will automatically stand cancelled without any further reference.

As such you are finally requested to get it checked and if any such employee have not been released they must be released on or before 15th December, 2017 failing which their selection will stand cancelled and they will be automatically reverted to their previous Designation/category.
