Subject- Banning of the firm M/s. JB Mining, H No. 72/1, School Para, Shilphili, Karsi, Pratappur, Sarguja, Chhattisgarh, from participating in the future tenders of SECL for a period of 01 year with immediate effect.

Name of work- Hiring of 02 no. Non- AC LMVs (Bolero, Scorpio or equivalent) on rental basis, with drivers for a period of 36 months (1095 days) for Gevra Project.

On GeM portal, custom bid no. GEM/2022/B/2496184 and custom bid no. GEM/2022/B/2496083 was floated for the work of "Hiring of one LMV for 36 months/1095 days for Gevra project", against each bid.

On conclusion of Technical and commercial evaluation, your firm JB Mining emerges as L-1 bidder in both the floated tenders and subsequently GeM contract order no. GEMC- 511687722022533 Dt. 16/01/2023 and GEMC- 511687725129138 dt. 17/12/2022 had been issued in favor of the L-1 firm JB Mining.

In accordance with the GeM contract order, your firm was required to start the service at the latest by 01/02/2023 against contract no. GEMC- 511687722022533 and by 01/01/2023 against contract no. GEMC- 511687725129138. In addition, you were also required to submit the requisite performance security within 21 days and enter into an agreement with the management for execution of work.

However, you have neither reported the vehicle nor submitted the performance security deposit for execution of the work within the stipulated time frame.

In this regard, suitable incidents have also been raised and matter have been reported to GeM authorities vide incident no. 1446210 and 1417388 (fails to furnish requisite performance security/ performance bank guarantee within stipulated time required as per e-bid/RA conditions) and incident no. 1446209 and 1424219 (delay in delivery). You have not responded to any of the show cause notices issued by the GeM authorities and has failed to provide suitable reasons to not carry out the work.

Accordingly, show cause notices were issued to your firm M/s. JB Mining; recognizing the principle of natural justice, a personal hearing was offered to you to present in the office of the GM (E&M), SECL, Gevra on any working day during office hours within 21 days from the date of issue of the notice for clarification regarding non deployment of vehicle and non-submission of PSD. (Show cause notice no. SECL/GA/SO(E&M)/22-23/2325 Dt. 10/03/2023 and Show cause notice no. SECL/GA/SO(E&M)/22-23/2214 Dt. 07/03/2023). The referred show cause notices remained un-responded from your end, within the specified time limit.

Non deployment of vehicle and non-submission of performance security has violated the following condition of the NIT and has attracted the following penal actions :-

a) Clause no. 04 - Performance security/ security deposit:

4.2 - Performance Security should be 3% of contract value and should be submitted within 21 days of issuance of LOA/ work order by the successful bidder.

However, Company may approve submission of Performance Security beyond 21 days by another 14 days with proper justification on a case-to-case basis.

In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled.

Additionally, the company shall ban such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter.

b) Clause no. 06 - Time for completion of contract - extension thereof, defaults & compensation for delay:

Immediately after the Bid of the contract is concluded, the Engineer-in-charge/Designated Officer-in-charge and the contractor shall agree upon time the order in which the work is proposed to be carried out within the time specified in the contract documents. For the purpose of this time and progress chart, the work shall be deemed to have commenced on the expiry of 10 (ten) days from the issue of letter of acceptance/work order or handing over the site of work whichever is later.

However, the Date of Commencement may be decided with mutual consent with the Contractor on any date after submission of performance security prior to the date as prescribed above.

6.1 If the contractor, without reasonable cause or valid reason, commits default in commencing the execution of the work within the aforesaid date, the company shall, without prejudice to any other right or remedy, be at liberty, by giving 15 days' notice in writing to the contractor to commence the work, failing which to forfeit Earnest Money, Performance Security Deposit and Additional Performance Security Deposit, if any deposited by him.

Additionally, the company shall debar such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum 1 (one) year from the date of issue of such letter.

The unavailability of the vehicle has hampered the day-to-day monitoring and maintenance activities, mandatory for the smooth functioning of the Gevra open cast mine. This inadequacy of the firm JB Mining has restricted the movement of manpower in the field area, which is not possible without the vehicles. This is indirectly resulting in loss in coal production; however, apparent loss is difficult to quantify.


In addition, retendering of the subject work has led to the award of work at a higher rate with an additional financial impact of Rs. 827191.00 (including GST) for 03 years.

In view of the above, the following actions as per the terms and conditions of the contract has been approved by the competent authority:-

- a) Termination of work awarded against GeM contract order no. GEMC- 511687722022533 dt. 16/01/2023 for Hiring of 01 no. LMV (Bolero/Sumo or equivalent), for a period of 03 years (36 months/1095 days) for Gevra Project.
- b) Termination of work awarded against GeM contract order no. GEMC- 511687725129138 dt. 17/12/2022 for Hiring of 01 no. LMV (Bolero/Sumo or equivalent), for a period of 03 years (36 months/1095 days) for Gevra Project.
- c) Banning of the firm M/s. JB Mining, from participating in the future tenders of SECL for a period of 01 (one) year from the date of issue of this letter.

A letter vide reference no. SECL/GA/SO(E&M) /23-24/164 Dt. 29/04/2023 and SECL/GA/SO(E&M) /23-24/165 Dt. 29/04/2023, has already been communicated to you from this office regarding termination of contract no. GEMC- 511687722022533 dt. 16/01/2023 and GEMC- 511687725129138 dt. 17/12/2022 awarded to your firm M/s. JB Mining.
