Dear Sir,

On GeM portal, bid no. GEM/2023/B/3137670 was floated for the work of Hiring of one LMV for 36 months/1095 days for Gevra project. On conclusion of Technical and commercial evaluation, your firm M/s. Samaru Das emerges as L-1 bidder among 15 other bidders participated in the tender and subsequently GeM contract order no. GEMC- 511687790393845 Dt. 20/04/2023 has been issued in favor of your firm M/s. Samaru Das.

In accordance with the GeM contract order, you were required to submit the requisite performance security within 21 days and enter into an agreement with the management for execution of work.

Cond..p/2

However, to date you have not submitted the performance security deposit for execution of the work.

In this regard, suitable incident has also been raised and matter has been reported to GeM authorities vide incident no. 1613575 (fails to furnish requisite performance security/ performance bank guarantee within stipulated time required as per e-bid/RA conditions).

Show cause notice has also been issued by the GeM admin on 31/05/2023, against the referred incident. You have not responded to the show cause notice issued and have failed to provide suitable reasons to not submit the performance security. A show cause notice was also issued to your firm, via mail, from the office of the undersigned, vide reference order no. SECL/GA/SO(E&M)/23-24/485 Dt. 16/06/2023, which you have failed to respond and provide justification for not submitting performance security. Besides you did not deploy any vehicle for operation against subject work order.

Accordingly, show cause notice was again served for the 3rd time through email, recognizing the principle of natural justice, a personal hearing was also offered to you to present in the office of the GM (E&M), SECL, Gevra on any working day during office hours within 21 days from the date of issue of said notice to explain regarding non submission of performance security within the stipulated period and non – commencement of work against GeM contract no. GEMC- 511687790393845 dt. 20/04/2023. (Show cause notice no. SECL/GA/SO(E&M)/23-24/614 Dt. 06/07/2023). The referred show cause notice remained un-responded from your end, within the specified time limit.

As such, you have not responded to any of the show cause notices issued and have failed to provide suitable reasons for not carrying out the work.

Non deployment of vehicle and non-submission of performance security has violated the following condition of the NIT and has attracted the following penal actions: -

a) Clause no. 11 of ATC - Security Deposit:

11.A - Performance Security should be 3% of contract value and should be submitted within 21 days of issuance of LOA/ work order by the successful bidder.

However, Company may approve submission of Performance Security beyond 21 days by another 14 days with proper justification on a case-to-case basis.

In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled.

Additionally, the company shall ban such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter.

b) Clause no. 12 of ATC:-

The service provider may be advised to contact Engineer-in-charge/Designated Officer-in-charge /Transport Manager, SECL HQ for commencing the work the work shall be deemed to have commenced from 10 (ten) days from the issue of GeM Contract or handing over the site of work whichever is later. However, the Date of Commencement may be decided with mutual consent with the Contractor on any date after submission of performance security prior to the date as prescribed above.

If the contractor, without reasonable cause or valid reason, commits default in commencing the execution of the work within the aforesaid date, the company shall, without prejudice to any other right or remedy, be at liberty, by giving 15 days' notice in writing to the contractor to commence the work, failing to forfeit Earnest Money, Performance Security Deposit and Additional Performance Security Deposit, if any deposited by him.

Additionally, the company shall debar such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum 1 (one) year from the date of issue of such letter.

The unavailability of the vehicle is hampering the day-to-day monitoring and maintenance activities, mandatory for the smooth functioning of the Gevra open cast mine. This failure on your part has restricted the movement of manpower in the field area, which is not possible without a vehicle. This is indirectly resulting in loss in coal production; however, apparent loss is difficult to quantify.

In addition, retendering of the subject work has led to the award of work at a higher rate with an additional financial impact of Rs. 1003239.00 (including GST) for 03 years.

In view of the above, the following actions as per the terms and conditions of the contract has been approved by the competent authority: -

- a) Termination of work awarded against GeM contract order no. GEMC- 511687790393845 dt. 20/04/2023 for Hiring of 01 no. LMV (Bolero/Sumo or equivalent), for a period of 03 years (36 months/1095 days) for Gevra Project.
- b) Banning of the firm M/s. Samaru Das, from participating in the future tenders of SECL for a period of 01 (one) year from the date of issue of this letter.

A letter vide reference no. SECL/GA/SO(E&M) /23-24/998 Dt. 05/09/2023 has already been communicated to you from this office regarding termination of contract no. GEMC- 511687790393845 dt. 20/04/2023 awarded to your firm M/s. Samaru Das.

This letter is to communicate the approval of the competent authority to Ban your firm <u>M/s.
