Subject:- Banning/debarring of your firm, M/s. Ramesh Prasad Singh from being eligible to submit bid in South Eastern Coalfields Limited for a period of 02 (Two) years with immediate effect.

Dear sir,

Whereas you have participated in Tender NIT No: SECL/GM/GA/SO(EnM)/e-Tender/21-22/37 dtd. 08.07.2021 against work as mentioned above. After being Techno-commercially acceptable L-1 bidder, your firm M/s. Ramesh Prasad Singh had been awarded the contract for " Work of cleaning of spillage Coal and slurry in various floors of Silo-1, 2, 3 and 4 of Gevra Project for a period of 365 days" vide LOA & LOI No: SECL/GA/E&M/21-22/LOA & LOI/1378 dtd. 18.09.2021.

As per **sub-clause 4.2** of **clause 4 "Security deposit"** of **Condition of Contract**, you had to deposit a sum of Rs. 55,156.00 as Performance Security Deposit within 21 days of issuance of said LOA & LOI. However, your firm did not submit the said Performance Security deposit within the given time frame. Letters bearing No: SECL/GVR/E&M/21-22/1509 dt. 01.10.2021 and No: SECL/GVR/E&M/21-22/1528 dtd. 06.10.2021 were also forwarded to you requesting you to deposit the required Performance Security Deposit within 21 days of issuance of LOA & LOI, still you fail to deposit the required Performance Security.

Subject:- Banning/debarring of your firm, M/s. Ramesh Prasad Singh from being eligible to submit bid in South Eastern Coalfields Limited for a period of 02 (Two) years with immediate effect

Observing the Principle of Natural Justice, you were served the show cause notice vide letter No: SECL/GA/SO(E&M)/21-22/1779 dtd. 22.11.2021 alongwith offer of Personnel hearing to explain your reason of non-compliance to the Terms and Condition of the contract within 15 days after receipt of this letter. Your explanation in this regard was not found satisfactory by Tender committee in light of Terms and Condition of contract.

Accodngly, your act has violated the condition as stipulated in clause – 4.2 of tender/NIT. The revant clause of the tender is quoted below for your reference -

Quote

4.2 Performance Security should be 3% of contract amount and should be submitted within 21 days of issuance of LOA by the successful bidder in any of the form given below -----

In case the successful bidder fails to submit the Performance Security,if any, within the stipulated time then the award of work shall be cancelled. The bidder(s) will be banned for 02 years for being eligible to submit bid in CIL and its subsidiaries with the approval of Tender accepting authority with intimation to all concern and online blocking of bidder ahall be done on receipt of written communication from the Tender inviting authority by application Admin of CIL e-procurement portal.

Additionally, the company shall ban such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter.

In case of JV/Partnership firm, the banning shall also be applicable to all individual partners of JV/Partnership firm.

Consequent upon non-acceptance of your reply by Tender Committee against Show Cause Notice and taking a serious view of your act of non-deposition of Performance Security Deposit amount against the awarded contract resulting in wastage of valuable time and efforts of management and delay in execution of cleaning work which was important to maintain coal dispatch to the consumer from Silos, the Competent Authority, has decided to cancelled the LOA & LOI and impose penalty of Banning / debarring your firm from participating in future tenders in SECL for a period of 02 (Two) years in line of the provision of clause -4 of Terms and Condition of NIT.

Accordingly, in light of the above illustrations, your proprietorship firm M/s. Ramesh Prasad Singh with **Registered address** – Gevra Basti, Kusmunda, District- Korba (C.G.), Postal code- 495678 having **Proprietor** – Ramesh Prasad Singh, **PAN** No. AEAPS7823K is hereby **banned from participating in future tenders in SECL for period of 02 (Two) years with immediate effect.**
