Dear Sir,

The SECL Gevra Area had floated tender vide reference no. NIT No: SECL/GM/GA/SO(ENM)/E-Tender/22-23/124 dtd. 17/02/2023 for work of "Dismantling, fabrication and erection of steel structure and replacement of damage CGI sheeting with profile sheeting from C3C4 Gantry to C3C4 Tail end and Transfer House of Back-up CHP of Gevra Project." After conclusion of technical and commercial evaluation, your firm M/s Jyoti Marketing & Engineering Services emerged as L-1 bidder, subsequently LOI was issued to your firm M/s Jyoti Marketing & Engineering Services vide reference no. LOA & LOI No: SECL/GA/E&M/23-24/LOA &LOI/291 dtd. 20/05/2023. Subsequent work order vide reference no. SECL/GA/SO(E&M)/23-24/WO/49 dtd. 12/06/2023 has been issued to your firm after deposition of requisite PSD and APSD amount of Rs.1847331.00 only (PSD Rs. 1,41,338.00 + APSD Rs. 17,05,983.00) in the form of common BG vide reference BG no. 39/2020 dated 09/10/2020.

After issuance of work order no 49 dated 12/06/2023, your firm M/s Jyoti Marketing & Engineering Services was required to commence the work within 10 days of issuance of work order or actual site hand over date and complete the work within 120 days.

The site handover letter was issued to your firm M/s. Jyoti Marketing & Engineering Services, Korba by Project Engineer(E&M), Gevra Project vide Letter No: SECL/GVR/E&M/23-24/B-258 dtd. 22.07.2023 to start the work w.e.f.- 01/08/2023.

1st reminder Letter No: SECL/GVR/E&M/23-24/B-300 dtd. 20/08/2023 was also issued by Project Engineer(E&M), Gevra Project to your firm, requesting to start the work immediately.

Subsequently, a letter was issued from the office of the undersigned via e-mail with letter no. SECL/GA/E&M/23-24/1090 dtd. 14/09/2023; advising your firm to start the work at the earliest and intimate to the office of SO(E&M), Gevra within 15 days. It was also advised to your firm that in case of non-commencement of work, suitable action as deemed fit as per provision of NIT and work order will be initiated without any further communication.

As the remainder letter no.1090 dt. 14/09/2023, remained not responded to from your end, a 2nd remainder letter no. SECL/GA/E&M/23-24/1398 Dt. 02/11/2023 was issued to your firm via mail from the office of the undersigned. Your firm M/s. Jyoti Marketing & Engineering Services, Korba failed to respond to any of the letters issued and commence the work as advised.

Accordingly, show cause notice was again served through email, recognizing the principle of natural justice, a personal hearing was also offered to you to present in the office of the GM (E&M), SECL, Gevra within 15 days from the date of issue of said notice to explain your stand regarding the non-commencement of work against work order no. SECL/GA/SO(E&M)/23-24/WO/49 dtd. 12/06/2023 and as to why penal action as deemed fit shall not be taken against your firm. (Show cause notice no. SECL/GA/SO(E&M)/23-24/1619 Dt. 05/12/2023). The referred show cause notice remained un-responded from your end, within the specified time limit.

As such, you have not responded to the show cause notice issued and have failed to provide suitable reasons for not carrying out the work, your firm M/s.Jyoti Marketing & Engineering Services, Plot No: 127, Behind H.P.O, Kosabadi, Korba, Distt.- Korba (495677) have violated the NIT clause as under :-

a. Clause No. 6.0 of General terms and conditions - Time for Completion of Contract, Extension thereof, Defaults and Compensation for Delay.

6.1. If the contractor, without reasonable cause or valid reasons, commits default in commencing the work within the aforesaid time limit, the company shall, without prejudice to any other right or remedy, be at liberty, by giving 15 days' notice in writing to the contractor to commence the work, failing which to forfeit the Earnest Money deposited by firm and to rescind the Letter of Acceptance of Tender / Work Order and also to debar the Contractor to take part in the future re-tender.

The Company may debar such defaulting Contractor from participating in future Tenders for a minimum period of 12(twelve) months.

b. Violation of relevant clause of ANNEXURE- I of NIT.

c. Violation of relevant clause of ANNEXURE- II of NIT.

Due to non - execution of the work, safety of the manpower has been compromised and SECL Gevra Area has to retender the work which has resulted into loss of time and efforts.

In view of the above, the following actions as per the terms and conditions of the contract has been approved by the competent authority: -



- a) Termination of work awarded to your firm M/s. Jyoti Marketing & Engineering Services, Korba, against order no. SECL/GA/SO(E&M)/23-24/W0/49 dtd. 12/06/2023.
- b) Forfeiture of security deposit submitted by your firm M/s. Jyoti Marketing & Engineering Services, Korba, of Rs. 1,04,000/- deposited vide TDR SL. No: SP 172796 & A/c No: 140019104620/10 dtd. 08.06.2023 and earnest money deposit of Rs. 68,600.00 only.
- c) Debarring of firm M/s. Jyoti Marketing & Engineering Services, Plot No: 127, behind H.P.O, Kosabadi, Korba, Distt.- Korba (495677) from being eligible to participate in future tenders of SECL for a period of 12 months/one from the date of issue of Debarring letter.

A letter vide reference no. SECL/GA/E&M/23-24/1827 Dt. 12/01/24 has already been communicated to you from this office regarding cancellation of contract no. SECL/GA/SO(E&M)/23-24/W0/49 dtd. 12/06/2023 awarded to your firm M/s. Jyoti Marketing & Engineering Services, Korba along with forfeiture of security deposits.

This letter is to communicate the approval of the competent authority to ban your firm **M/s. Jyoti Marketing & Engineering Services, Plot No: 127, behind H.P.O, Kosabadi, Korba, Distt.- Korba (495677)**, with **PAN** - AHFPR8981D and **GSTIN** - 22AHFPR8981D1Z5), from being eligible to participate in the future tenders of SECL for a period of 01 (one) year from the date of issue of this letter.
