**Subject:-** Banning of Proprietorship firm, M/s. Singh Om, Dipka from being eligible to submit bid in tenders of South Eastern Coalfields Limited for a period of 02 (Two) years with immediate effect.

Dear sir,

An open tender was invited on GeM portal by the office of the General Manager / Staff officer (E&M), Gevra Area vide GeM Bid No: GEM/2023/B/3834643 dtd. 16.08.2023 for the work of "Hiring of 02 nos. Non-AC (Bolero, Sumo, Scorpio or equivalent) on rental basis with Drivers for a period of 36 months (1095 days) for Gevra Project, SECL".

In the tender, proprietorship firm M/s. Singh Om, Dipka had participated and on conclusion of Technical and commercial evaluation, the firm M/s. Singh Om, Dipka emerges as L-1 bidder among 16 other bidders participated in the tender and subsequently GEM contract No: GEMC-511687798151137 dtd. 27.10.2023 has been awarded to the firm M/s. Singh Om, Dipka.

In accordance with GeM contract order, the firm M/s. Singh Om, Korba was required to submit the requisite Performance Security deposit of Rs. 1,45,516/- and Additional Performance Security Deposit Rs. 5,35,603/- within 21 days and enter into an agreement with the management for execution of work.

The firm M/s. Singh Om, Korba did not submit the said Performance Security & Additional Performance security deposit within the given time frame for work execution.

Accordingly, Show Cause Notice was served through e-mail, recognizing the principle of Natural Justice, a personal hearing was also offered to firm to present in the office of the GM(E&M), SECL, Gevra Area on any working day during office hours within 21 days from the date of issue of this notice to explain regarding non-submission of Performance Security & Additional Performance Security deposit within the stipulated period against GeM No: GEMC- 511687798151137 dtd. 27.10.2023 (Show cause Notice No: SECL/GA/SO(E&M)/23-24/1635 dtd. 10.12.2023). The referred show cause notice remained un-responded from your end, within the specified time limit.

The firm M/s. Singh Om, Dipka has not responded to the Show cause notice issued and has failed to provide suitable reasons for non-submission of Performance Security deposit of Rs. 1,45,516/- and Additional Performance Security deposit of Rs. 5,35,603/- within the stipulated period against GeM contract No: GEMC-511687798151137 dtd. 27.10.2023.

The non-submission of Performance Security deposit & Additional performance Security deposit has violated the following conditions of NIT and has attracted the following Penal actions:-

#### Quote

#### **A) Clause No: 11 of ATC – Security Deposit :**

11.A – Performance Security should be 5% of contract value and should be submitted within 21 days of issuance of LOA/Work order by the successful bidder.

However, Company may approve submission of Performance Security beyond 21 days by another 14 days with proper justification on case-to-case basis.

In case, the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled.

Additionally, the Company shall ban such defaulting Contractor from participating in future tenders in concerned Subsidiary / CIL HQ for a period of minimum one year from the date of issue of such letter.

#### **B) Clause No: 12 of ATC – Additional Performance Security :-**

Additional Performance Security shall be applicable if the bid price is below 15% of the estimated cost put to tender. The amount of such additional performance security shall be the difference between 85% of the estimated cost put to tender and quoted price.

Additional Performance Security (APS) shall be furnished within 21 days of issuance of LOA by the successful bidder.

Work shall commence only after submission of Performance security and Additional Performance security, if any.

Failure to submit such additional performance security shall result in cancellation of the contract with forfeiture of earnest money.

The Company may debar such defaulting Contractor from participating in future tenders in concerned Subsidiary / CIL HQ for a period of minimum one year from the date of issue of such letter.

Consequent upon non-response against the opportunity provided in Show Cause Notices, Tender Committee recommended to take action of debarring of firm from being eligible to participate in future tender of SECL for a period of 02 (Two) years. Consequently, in line of the provision of subsequent clause – 11 and 12 of ATC of the NIT floated.

The non commencement of work by M/s. Singh Om, Korba has resulted into termination of contract and has led to wastage of valuable time and efforts of management and delay in execution of work.

Accordingly, the Competent Authority, decided to impose penalty of Banning the firm M/s. Singh Om, Dipka, Korba from being eligible to participate in future tenders of SECL for a period of 02 (Two) years from the date of issue of this order. The GeM contract No: GEMC-511687798151137 dtd. 27.10.2023 has already been cancelled vide letter reference no. SECL/GA/SO(E&M)/23-24/1888 dtd. 20.01.2024.

Now from this letter the proprietorship firm **M/s. Singh Om** with Registered address – Ward No: 03, Katghora, Jyoti Nagar, Pali Road, Village/Town – Dipka, City- Korba, Chhattisgarh – 495452 having Proprietor – Om Prakash Singh, PAN No. DNJPS3730Q is hereby **debarred from being eligible to participate in future tender of SECL for a period of 02 (Two) years with immediate effect.**
