An open tender was invited online through e-tendering by the office of the General Manager /Staff officer (E&M), Gevra Area vide NIT No: SECL/GM/GA/SO(ENM)/E-Tender/21-22/05 dtd. 10.04.2021 for the work of "Work of Belt jointing, Pulley lagging, Cross jointing steel cord belting and longitudinal joints (through cut repairing) steel cord belting at Back-up CHP at Gevra Project"

In the tender, proprietorship firm M/s. Dwaba Infratech, Korba had participated and after being established Techno-commercially acceptable L-1 bidder, M/s. Dwaba

Infratech, Korba had been awarded the contract vide LOA & LOI No: SECL/GA/E&M/21-22/LOA & LOI/794 dtd. 12.07.2021.

As per **sub-clause 4.2 of clause 4 of "General Terms and Condition"** of the tender under heading "**Security deposit**" the firm had to deposit a sum of Rs.75,552.00 as Performance Security Deposit within 21 days of issuance of said LOA & LOI. Further as per **sub-clause 6.1 of clause 6 of "General Terms and Condition"** of the tender under heading "**Time for completion of contract, Extension thereof, Defaults and Compensation for Delay**" the contractor M/s. Dwaba Infratech, Korba had to commence the work within 10 days of issuance of the said LOA & LOI.

However, M/s. Dwaba Infratech, Korba neither submitted the said Performance Security within the given time frame nor did he commence the work at site. Due to the failure on the part of the contractor, M/s. Dwaba Infratech, Korba he was requested vide Letters ref No: SECL/GA/E&M/21-22/838 dtd. 16.07.2021 to submit the required performance security and again vide letter ref no. SECL/GA/E&M/21-22/875 dtd. 23.07.2021 he was requested to deposit required Performance Security. When no action was visible from the side of the contractor towards deposition of Performance security and commencement of work, the contractor M/s. Dwaba Infratech was again requested to deposit the required Performance Security vide letter ref No: SECL/GA/E&M/21-22/933 dtd. 29.07.2021.

When all the above-mentioned correspondences yield no result, observing the principle of Natural Justice the SECL Gevra Area Management served the show cause notice vide letter No: SECL/GA/SO(E&M)/21-22/1064 dtd. 13.08.2021 which remain un-responded. Again 2nd Show cause Notice No: SECL/GA/SO(E&M)/21-22/1508 was issued on 01.10.2021 along with offer of Personnel hearing to the contractor to explain the reason of non-compliance to the Terms and Condition of the contract within 15 days after receipt of said letter. However, contractor neither replied to the show cause notice nor appear before the authority for personal hearing against the opportunity provided.

Accordingly, the act of non-submission of performance security by the contractor M/s. Dwaba Infratech, Korba has violated the condition stipulated in clause – 4.2 of General Terms and Condition of the Tender. The relevant clause of the tender is quoted below for reference -

Quote

4.2 Performance Security should be 3% of contract amount and should be submitted within 21 days of issuance of LOA by the successful bidder in any of the form given below -----
-----In case the successful bidder fails to submit the Performance Security, if any, within the stipulated time then the award of work shall be cancelled. The bidder(s) will be banned for 02 years for being eligible to submit bid in CIL and its subsidiaries with the approval of Tender accepting authority with intimation to all concern and online blocking of bidder shall be done on receipt of written communication from the Tender inviting authority by application Admin of CIL e-procurement portal. -----
In case of JV/Partnership firm, the banning shall also be applicable to all individual partners of JV/Partnership firm.

Due to failure on the part of the contractor M/s. Dwaba Infratech, Korba to submit the required performance security, Company (SECL) has no option left other than to cancel the LOA/LOI and take penal action as per condition of award/Notice inviting tender.

The cancellation of the instant award of work has led to execution of subject work at higher value of Rs. 66,47,300/- without GST as compared to the value at which instant work was awarded besides there had been wastage of valuable time and efforts and delay in execution of work which was important to maintain CHP/Back-up of Gevra and to maintain smooth coal dispatch to the consumer from Silos.

Accordingly, the Competent Authority, decided to cancel the LOA & LOI and impose penalty of Banning / debarring the firm M/s. Dwaba Infratech, Korba from being eligible to participate in future tenders of SECL for a period of 02 (Two) years from the date of issue of such debarring order in line of the provision of clause - 4 of Terms and Condition of NIT. The LOA & LOI No. SECL/GA/E&M/21-22/LOA & LOI/794 dtd. 12.07.2021 was cancelled vide letter reference no. SECL/GA/E&M/21-22/2002 dtd. 26.12.2021.

Now from this letter the proprietorship firm **M/s. Dwaba Infratech** having Registered address – Plot No: 120, Ramayan Kosabadi, Korba, District- Korba (C.G.), Postal code- 495677 Proprietor – Piyush Kumar Tiwari, PAN No. AVLPT4587D is hereby **banned/debarred from being eligible to participate in future tender of SECL for a period of 02 (Two) years with immediate effect.**

However, contractor neither replied to the show cause notice nor appear before the authority for personal hearing against the opportunity provided.

Due to failure on the part of the contractor M/s. Shree Krishna Traders and Transporter to submit the required performance security, Company (SECL) has no option left other than to cancel the LOA/LOI and take penal action as per condition of award/Notice inviting tender.

The cancellation of the instant award of work has led to subsequent award of work at higher value of Rs. 2,19,160.60 (Two lac nineteen thousand one hundred sixty and paise sixty only) as compared to the value at which instant work was awarded beside there had been wastage of valuable time and efforts of management and delay in execution of cleaning work which was important to maintain coal dispatch to the consumer from Silos which has further resulted into loss of the company. Loss of time of more than two months was there in completing the process of retendering.

Accordingly, the Competent Authority, decided to cancel the LOA & LOI and impose penalty of Banning / debarring the firm M/s. Shree Krishna Traders and Transporter from participating in future tenders in SECL for a period of 02 (Two) years from the date of issue of such debarring order in line of the provision of clause -4 of Terms and Condition of NIT. The LOA & LOI No. SECL/GA/E&M/21-22/LOA & LOI/255 dtd. 10.05.2021 was cancelled vide letter reference no. SECL/GA/E&M/21-22/2261 dated 25.01.2022.

Now from this letter the proprietorship firm **M/s.
