The above referred NIT was called by the office of undersigned, and the offer was submitted by you in response to the above tender notice accepting all the terms and conditions of the tender.

As per clause no. 14.2 of Terms and conditions, "Additional performance security (APS) shall be furnished within 21 days of issuance of LOA by the successful bidder.

Failure to submit such additional performance security shall result into cancellation of the contract with forfeiture of earnest money."
