Sub: - Banning / Debarring of your firm from participating in future tenders in South Eastern Coalfields Limited for a period of 01 Year (12 months) with immediate effect.

Dear Sir,

You had been awarded the GeM Contract order no. GeM Contract no. GEMC-511687780365731 dtd 25.04.2023 & LOI no. SECL/GM/RGH/E&M/LOI/23-24/04 Dtd 25.04.2023 for the work "Hiring of 01 no. Diesel jeep (Scorpio/Bolero or equivalent) on 24 hrs engagement basis for a period of 03 Years/36 months (1095 days) for jampali Open Cast project, SECL, Raigarh Area. As per following details-i. Hours of Engagement of vehicle per day- 24 Hrs, (3 shifts/day),ii. Fuel efficiency- 10 km/liter,,iii. Average running- 130 km/ day,iv. No. of drivers/ day - 03 drivers/ day/ vehicle, Total Nigh Half per month per vehicle - N. A..Total Extra Hours per month per vehicle - N. A. . In accordance with Clause no. 11 A of ATC, you had to submit the performance security deposit within 21 days of issuance of LOI. However you failed to submit the PSD within given time frame even after issuance of reminder from our end .

Further an incident was raised on GeM portal and matter was reported to GeM authority vide incident no. 1613931 . A show Cause Notice was issued to your firm from GeM . But you have not responded the show cause notice and as a consequential action your GeM account had been suspended by the GeM .

Therefore , in pursuance of clause no. 11 of ATC , the reference contract awarded to you had been cancelled on GeM portal . A show cause notice was also served to your firm via mail /Registered post from the office of the under signed vide reference no. SECL/GM/RGH/E&M/23-24/508 dtd 04.10.2023 but you not responded . Again show cause notice was served to you for 2nd time through mail/Registered post vide ref no. SECL/GM/RGH/E&M/23-24/554 dtd 20.10.2023 but , you not responded through any communication means .

Due to non submission of performance security & non deployment of vehicle, Management was of the opinion to take action against you as per clause no. 11 A , Clause no. 12 of Additional terms & conditions and Clause 2.ii of Guideline for Banning of Business which are quoted below —

<u>Quote</u>

Clause no. 11 A of ATC

In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled. Additionally, the company shall ban such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum one year from the date of issue of such letter.

Clause no. 12 of ATC

If the contractor, without reasonable cause or valid reason, commits default in commencing the execution of the work within the aforesaid date, the company shall, without prejudice to any other right or remedy, be at liberty, by giving 15 days' notice in writing to the contractor to commence the work, failing which to forfeit Earnest Money, Performance Security Deposit and Additional Performance Security Deposit, if any deposited by him.

Additionally, the company shall debar such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum 1 (one) year from the date of issue of such letter. In case of JV/Partnership firm, the debarment shall also be applicable to all individual partners of JV/Partnership firm.

Clause 2.ii of Guideline for Banning of Business

2. The contracting entity may be banned in the following circumstances:-

ii) If L-1 bidder fails to submit PSD and APSD (if applicable), if any and/or fails to execute the contract within stipulated period.

Management has taken a serious note on non submission of requisite PSD within time frame & non execution of work and decided to take action for debarment /banning of your firm from participating in future tender in SECL for a period of (01) year in line with the provision of clause mentioned above. The unavailability of vehicle hampered the day to day monitoring and maintenance activity required for smooth functioning of Mine, which indirectly affected the production & productivity of the mine and also wasted useful time & effort of the Management in the process of Re tendering.

In addition , retendering of the subject work has led to the award of work at a higher rate with an additional financial impact of Rs. 8,80,596 /- (including GST) for 3 years .
