The above work was awarded to you vide LOA No.SECL/BSP/CMC/e-T471/Re (2nd call/LOA) MadannagarMDO/Bhat/2022-23/719 dated 24.12.2022 & conigendum (LDA) No. SECL/BSP/CMC/e-T471/Re(2nd call/LOA/MadannagarMDO/Bhat/2022-23/728 dated 28.12.2022 issued by GM(CMC), SECL, Bilaspur. You were instructed to deposit the PSD amount and execution of Agreement within 90 days from the date of issue of LOA but you neither submitted the PSD amount and not executed the agreement within the time period even after issuance of several letters. Further, you have been issued a final notice for intention for termination of contract with forfeiture of bid security/EMD, debarring for a period of one year with an advise to present your defence within 15 days from the date of issuance of the letter in writing or in person. But neither you have submitted any letter in writing nor contacted this office for defence. Besides, you have been given the opportunity of personal hearing and your authorised representative attended this office on 17.07.2023 and responded with letter & emails. Thus, reasonable opportunity has also been given to represent against this action.

In view of the above fact and circumstances, as per the terms & conditions of MCA and RFB, following action have taken against you:

- a) Termination/Carcellation of LOA No.SECL/BSP/CMC/e-T471/Re (2<sup>nd</sup> call/LOA/ MadannagarMDO/Bhat/2022-23/7)9 dated 24.12.2022 & susequent corrigendum (LOA) No. SECL/BSP/CMC/e-T471/Re(2<sup>nd</sup> cd|/LOA/MadannagarMDO/Bhat/2022-23/728 dated 28.12.2022 issued by GM(CMC), SECL, Bilaspur
- b) Forfeiture of bid security/EMD (Earnest Money Deposit) amounting to Rs.2,00,00,000.00 (Two Crore) only diposited by you vide e-Procurement ref.No.223089738458 and Bank/UTR No.93183329.
- c) Debarring and black listing from participating in any bids/tenders floated by South Eastern Coalfields Limited for a period of 1 (one) year effective from the date of issue of this letter.
