Dear Sir,

A tender was floated on e-procurement portal of Coal India vide ref. tender ID - 2023\_SECL\_277905\_1 and E-NIT ref. SECL/GA/e-Tender/23-24/01 dtd. 25.04.2023, for the work of Repairing of 02 no Idler assembly (P/N 58357537) of PV351E drill working at Gevra project as per scope of work". In the said tender you have submitted your bid with reference ID - 946052.

In the bid, your firm M/s. R P Engineering, Raiagrh emerged as L-1 bidder among three (03) participated bidders, as the bid being below 50 lakhs, documents form only L1 bidder is scrutinized.

In process of technical scrutiny, it was observed that bidder has submitted an incomplete work order of value Rs.4,71,332.00 with out work completion certificate. Hence, the same has been requested from the bidder after approval from tender committee.

On submission of the confirmatory document from the bidder the work order along with work completion certificate was issued for only Rs.1,71,332.00, after approval of the committee the case was referred to the legal department for course of action and it was recommended to initiate the action of debarring after following all legal formalities.

Show cause notice has also been issued to the bidder and the consequent reply has been received from you was found unsatisfactory and the same has been reverted to you.

As such, you have responded to the same and have failed to provide suitable reasons / new facts.

The bidder has violated the following condition of the NIT and has attracted the following penal actions: -

a) clause 3 of Undertaking of Annexure XV:


If any information and document submitted is found to be false/ incorrect at any time, department may cancel my/our Bid and action as deemed fit may be taken against me/us, including termination of the contract, forfeiture of all dues including Earnest Money and banning of our firm and all partners of the firm etc.

Show cause notice for banning has been issued in accordance to Point vi "Wilful suppression of facts or furnishing or wrong information or manipulated or forged documents by the Agency or using any other illegal/unfair means" in clause 19. Guidelines for Banning of Business of GTC.

In view of the above, the following actions as per the terms and conditions of the contract has been approved by the competent authority: -

- a) Banning of the firm M/s. R P Engineering, from participating in the future tenders of SECL for a period of 02 (one) year from the date of issue of this letter.
